CONSENT, WAIVER, AND RELEASE

PLEASE READ CAREFULLY

THIS IS A LEGAL DOCUMENT. BY SIGNING THIS DOCUMENT THE PARENTS/GUARDIANS AND YOUNG PERSON (THE "PARTICIPANT") ARE GIVING UP CERTAIN LEGAL RIGHTS AND ASSUMING CERTAIN OBLIGATIONS. THOUGH THE CHURCH WILL UNDERTAKE PRECAUTIONS, ACCIDENTS OCCUR AND THIS AGREEMENT MUST BE SIGNED IN ANTICIPATION OF THAT POSSIBILITY.

In consideration of Bethel Mennonite Church sponsoring, facilitating or being involved with various activities/functions/events with the Participant from the undersigned parents/guardians and Participant hereby (cont'd):

Assumption of Risk & Waiver

- (a) acknowledge that involvement in and access to some or all of these activities/functions may involve private and/or public transportation;
- (b) understand that these activities/functions and transportation to and from them may involve risks of harm to the Participant;
- (c) understand that unintended injuries and death may possibly result as a consequence of participation in such activities/functions and transportation to and from them;
- (d) accept full risk and responsibility for the death of or injury to the Participant or damage to the property of the Participant arising from the activities/functions or transportation of the Participant to and from such activities/functions;
- (e) waive any rights whatsoever that the undersigned and Participant may have now or in the future against the Church and, as applicable, its members, directors, officers, leaders, agents, volunteers and employees as a result of death or injury to the Participant or damage to the property of the Participant arising from the participation in the activities/function or transportation to and from them;
- (f) release, forever discharge and covenant not to sue the Church, its members, directors, officers, leaders, agents, volunteers and employees in relation to all liability, actions, causes of action, suits, claims and demands whatsoever that may arise from any activities/functions or transportation to and from them, however caused or arising;
- (g) agree and understand that this document will be binding on the heirs, executors, administrators and assigns of the undersigned parents/guardians and the Participant;
- (h) indemnify and hold harmless the Church, its members, directors, officers, leaders agents, volunteers and employees from any liability actions, suits, claims, demands whatsoever, arising from any negligent, wrongful or illegal act or omission of the Participant in respect of any activities/functions or transportation sponsored, arranged or coordinated by the Church or its agents;
- (i) understand that the risk of the Participant becoming exposed to or infected by COVID-19 at the Church may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Church employees, volunteers, attendees, program participants and their families. I agree while on premises or while participating in off-premises activities events of the Church that the Participant will abide by all rules and recommendations posted in signs on the premises and otherwise communicated in writing or verbally by the Church, its directors, officers, employees and volunteers, to protect my health and safety. I

voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any illness or injury to the Participant including, but not limited to, personal injury, disability, death, damage, loss, claim, liability, or expense, of any kind, that the Participant may experience or incur in connection with the Participant's attendance at the Church or participation in its events, programs or activities.

Medical Emergencies

- (j) agrees that in the event of a medical emergency permission is granted to the Church and the Church's leaders to authorize necessary emergency treatment for the Participant, and that all costs and expenses incurred in connection with such medical treatment will be the responsibility of the Participant and their parent/guardian; and
- (k) agree that if any provision hereof is invalid, illegal, or incapable of being enforced by reason of any rule of law or public policy then such provision will be served from and will not affect any other provision contained herein, and this instrument will be read as if such invalid, illegal or unenforceable provision had never been contained herein and all other provisions hereof will, nevertheless, remain in full force and effect and no provision will be deemed to be dependent upon any other provision.
